**Important notes**

**Language proficiency check**

The repetition of a failed Language Proficiency Check (result < Level 4) shall be carried out in the same exam centre as the previous examination. Exceptions are subject to prior permission by FOCA. Candidates who fail the Level 4/5/6 exam are not obliged to retake the Level 4/5/6 exam. They may, if they wish, enrol for the Level 4 exam only (use FOCA form 69.510). A copy of the failed Language Proficiency Check form must be attached to the enrolment for repetition.

**RTF observation**

- If RTF is **marginal**, the test taker is **recommended** to participate in an RTF Refresher course.
- If RTF is **insufficient**, the test taker is **required** to participate in an RTF Refresher course as soon as possible and send a copy of the course certificate to FOCA. If the test taker does not comply with this requirement within 12 months of the date of the Language Proficiency Check, radiotelephony privileges will be revoked and the test taker will be obliged to repeat the RTF exam.
