The aircraft may be put into operation thereafter.

- Blue documents-binder, containing all on-board documents
- For corporate entities: extract from the commercial register
- For foreigners: residence permit B or C
- If applicable, the insurance certificate
- If applicable, the aircraft maintenance programme
